### What is LDAC? Jennifer O'Neill, SRA

While at the Appraisal Institute conference in Orlando, I was hanging out by the pool with a new group of people I had met there at the conference. "LDAC, LDAC, LDAC", I kept hearing. And finally, I had to ask. "What is LDAC"?

Well, I quickly learned that LDAC is short for "Leadership Development and Advisory Council." It is a program within the Appraisal Institute designed to identify and develop future leaders within the organization, and to provide them with opportunities to contribute to governance and strategic initiatives. It offers a platform for Appraisers to cultivate leadership skills, enhance professional development, and promote networking within the group.

Each year, up to 125 participants are selected to meet in Washington, DC. The participants include a mix of 1st year, 2nd year, and 3rd year people, along with the Leadership Committee.

To be considered, you begin with the online application form. (This requires a headshot, by the way...I laugh at my photo, which gets used for the group EventMobi app, because the online application day was Valentines Day, and I was dressed in pink and red). In my rush to apply as soon as it opened online, and to secure a spot, I hadn't really thought to have a professional photo on hand. This year the application fee was \$680. After acceptance, you then need to book the DC hotel. Looking back, the total cost for the two hotel nights was under \$800. Next step is to determine the best way to get there. From Connecticut, I had the option to take the Acela train, which was overall the easiest. Each Appraisal Institute Chapter has its own policy on reimbursement for the trip. Some chapters regularly send multiple people, and some haven't sent anyone in a while.

If you decide to go to LDAC, they say don't bring any work, you won't have time to do it. And that is correct. They pack a lot into the two and a half days, and everyone needs to be present. I was able to take the train that Wednesday morning, Lyft to the hotel, and store my suitcase. Registration started at 11am and at 12:30 there was a meeting for all First Years. Then we all met together for opening remarks, with the Appraisal Institute Leadership there in full force. You also get to meet key staff members that make the magic happen! We had an afternoon Lobbying Information session to prepare us for the actual Congressional office visit we would be making. That was followed by a reception. But it didn't stop there. There was a sponsored social that lasted into the night, at a local venue. And people met up after in the hotel bar area. It is a great opportunity to get to know peers outside a work environment.

Thursday was packed solid again. Breakfast started at 7am and Round Tables at 8am. There were four discussion leaders and participants went through each of the four sessions. Two were on Thursday morning and two on Friday morning. Thursday afternoon consisted of making the Congressional visits, which you arranged ahead of time. It was fun to walk through the Capital buildings and around DC to get a look at how lobbying works. We all met for a group photo at the Capitol. After that we were off to another reception, and then people went out to dinner. Friday had two more Round Table discussions. Round Tables are discussions on current events and issues, which we use as a think-tank to solve as a group. The day ended with closing remarks and voting for the 2025 Discussion Leader.

There is a special bond with all the Discussion Leaders that only could have happened with the shared experience LDAC offers. Discussion Leaders included Jorge Barreiro, SRA, AI-RRS, Hugh "Bo" Bass, Jr, MAI, Smedmore Montgomery Bernard, Jr, MAI, and Molly Skipper Steel. They all excelled and showed passion for their roles as Discussion Leaders. Alternates Kelly Hyde, MAI and Lucas Rotter, Practicing Affiliate, led the First Year introductions. I met for the first time LDAC Vice Chair Kelly Yeats, MAI and LDAC Chair Eric Schneider, MAI, SRA, AI-GRS. Kelly Yeats will Chair LDAC next year, and Smedmore Bernard, Jr, MAI, was elected Vice Chair for 2024. The environment this group created was welcoming and open, and Jorge made it clear that we are all a part of the LDAC family. My thanks go to Bo, who was one of the people at the Orlando pool, and the reason I went to LDAC.

If you haven't participated in LDAC, I highly recommend you try it. I met a lot of people who all care about and work hard in our industry. It was a unique experience to see firsthand how lobbying works. Thanks to Alie Smeltzer, SRA, AI-RRS, who helped me figure out before the conference how to contact my representatives, request meetings, and looked out for me the whole way. Thanks also to John Musnuff, MAI, who went to the Congressional meetings with me. They both helped make my experience great. It is that spirit of helping and learning, and being able to lean on people I may not have known before, that made me realize we all have a network and peers who want us to succeed.

### Appraisal Institute PAREA Program Receives Approval from Appraiser Qualifications Board

CHICAGO (May 18, 2023) — The Appraisal Institute announced today that the Appraiser Qualifications Board has provided approval of Al's Practical Applications of Real Estate Appraisal program for the licensed residential path.

The Appraisal Foundation's Board of Trustees awarded the Pathway to Success Grant to the Appraisal Institute to assist with the development of the PAREA program. The Pathway to Success Conditional Grant is designed to open up the appraisal profession to a new generation of appraisers and stipulates that participant priority be given to veterans, minorities and those in designated rural areas. Al was awarded the full grant amount of \$500,000 to build its Al PAREA program in collaboration with its partners. Al committed more than \$2 million toward Al PAREA.

PAREA, which is an online program, is an alternative pathway for aspiring appraisers to gain their required experience hours to become a licensed or certified appraiser. Historically, the only option for an appraiser to complete their experience hours was through a supervisor/trainee model that requires the aspiring appraiser to find their own supervisor. PAREA is currently accepted 43 states, and that number is likely to increase as more states adopt this alternative pathway.

### Key elements of AI PAREA include:

- Participants will be supported throughout the program by mentors who are Appraisal Institute Designated Members and full-time employees of the organization. The Appraisal Institute specifies rigorous requirements for Designated membership regarding experience, education and moral character and those individuals demonstrate the highest standards of education and ethics.
- Al PAREA participants will have access to the organization's 66 chapters to enhance networking opportunities and connect with appraisers who can potentially help participants become geographically competent, meaning that participants can learn about the specifics of local markets from appraisers with that knowledge and experience.
- In addition to the basic specification of three Uniform Standards of Professional Appraisal Practice (USPAP)-compliant
  reports established for PAREA programs by the AQB, AI PAREA features an additional 10 practice assignments and reports
  The assignments are consistent for all participants and include a variety of complexity and property types to reinforce
  important appraisal concepts and skills.
- The assignments that are part of AI PAREA are developed by an organization with a 90-plus-year history of creating best-in -class education, publications and other appraisal products.
- Al PAREA participants have access to a knowledge center that includes a variety of resources that appraisers use every day including forms software and a multiple listing service (MLS).

"The AQB's approval of AI PAREA for the licensed residential path is a significant milestone for our organization and the entire valuation profession," said Appraisal Institute President Craig Steinley, MAI, SRA, AI-GRS, AI-RRS. "This program will create many opportunities for aspiring appraisers who might not currently have a pathway into the profession."

"The Foundation is so pleased to see the first PAREA program receive approval from the Appraiser Qualifications Board," said The Appraisal Foundation President David S. Bunton. "The introduction of this program to the marketplace opens a new pathway for aspiring appraisers, and we look forward to welcoming PAREA participants to the appraisal profession."

AI PAREA will initially welcome select participants during the pilot program phase, who have completed their Qualifying Education and reside in a state which has fully accepted PAREA in lieu of the traditional supervisor/trainee model. AI PAREA is expected to launch broadly and make registration available by September 2023
